ONGOING ISSUES

Ousefleet Community Hall. Report from the OVHC committee. J Woodcock said the toilets were near completion as was the kitchen. Just awaiting final plumbing work, the new entrance radiator is to be fitted. The drainage issues have been looked at by ERYC. Len Turner to come and authorise. The ramp is more of a slope and volunteers are available to carry out work on this. ERYC will come and check the work to ensure all conditions being met.

Playground inspection by ERYC and signage in Ousefleet. No review until 2019 by ERYC. Noted. J Reed working for A Percy MP has said she can be contacted for help with fencing.

Ideas for Grant applications from Goole Fields.

Grant of £1000 for legal fees has been received. Cllr Scrimgeour asked that the Clerk investigate the legal information regarding the existing lease at the village hall. The parish council need confirmation from the hall committee as to what is needed. The grant information i.e. receipts, and legal costs need to be returned by 31 March 2018.

COUNCILLOR ISSUES

Adoption of Disposal policy. Resolved to adopt the policy which had been prepared by ERNLLCA.

Fencing at the Playground. Contact Number is recommended. Resolved to leave the play area as it is for now. Cllr Spurgeon will note any problems at the site for the parish council during the summer months by making visual site inspections and reporting any concerns to the Clerk.

The police have started a recruitment drive and the pay rise will be 6.4% for Band D properties.
