29.2 Ousefleet Village Hall. Report from M Dargan project manager. A quote for electrical work is being sought. No work has commenced on the site to date. The planning application 17/02809 is proceeding with ERYC. The building control partnership has visited the hall after sending post to the hall. The schedule of works is ongoing and it has been agreed that the toilets should be in situe before any plumbing work is carried out. There are electrical stores which can be used by the electrician. M Dargan was asked to get upto date quotes for the next meeting with as much detail in the quotes as can be given. M Dargan will take photographs on site and in the coming months to record work in progress. Meeting with Planman is ongoing.

29.3 Dog Bin near Whitgift Church. Councillor S Woodcock has met with ERYC and this will be arriving shortly with 50% costs allocated by Reedness Parish Council. The dog bin will be sited near the salt bin at Whitgift Church.

29.4 Defibrillator Adlingfleet.Councillor J Reed will assist but has been off ill. The Clerk has obtained details of a National Lottery application and will take forward.100% funding may be possible.

29.5 Grant applications. The invoice for the Goole fields grant has been issued.Upto date position to be sought.

29.6 Playground signage in Ousefleet.ERYC will make an inspection later this month and send a report.
