ONGOING ISSUES

Ousefleet Community Hall. Report from the OVHC committee. S Woodcock gave everyone an update. The volunteers are overseeing the new toilet entrance and the flooring for the new kitchen area will be laid in the coming week. The electrician will also be visiting the hall to start work. The committee are not operating on the out of date constitution.

M Dargan report as project manager of the community centre work. Walkers have quoted for work required which the volunteers cannot now undertake. Thicker wall to break through. The costings for the phase one work are looking different but money is being saved and money spent to complete the project within budget. A drainage contractor will have to be sought for work which the volunteers cannot undertake. The parish councillors are to try for the least monetary quote. The ramp and stairs need more handrails installing. The clerk has written to the vat office to determine the accurate position re the vat incurred on the building works.

Playground inspection by ERYC and signage in Ousefleet playpark. Cllr J Spurgeon has walked around and inspected the playground and will be provided with a book to record inspections. Only the seat is an issue. The clerk has contacted ERYC and it is hoped they will visit shortly to advise re signage for dog fouling.

Visit to Cow Lane by parish councillors. Constitution needs to be located if possible. The parish councillors will postpone a visit until spring. Cow Lane is 64 acres and the parish council have grazing rights on this. It is registered as public space.

Ideas for Grant applications from Goole Fields. Starts January 2018. Coordinator A Scrimgeour. Large funds over a wider area are to be announced in the New Year. Grants will be available 4 times a year but for specific projects.

Update grant £1000 for legal fees. None available despite Clerk sending the information to the grant body in September and emails since.
