29/1819 ONGOING ISSUES

29.1 Ousefleet Community Hall. A recent quiz raised £100. A grant application for a hall projector is being prepared. A grant application for the show is also being prepared.

29.2 Amendment to the lease of the hall. Symes Bains Broomer have been contacted and their full comments and recommendations will be available at the next meeting. The parish council have received a £1000 grant for this work.

29.3 Adlingfleet Defibrillator. Training took place on the 6 June 2018 at Adlingfleet Church. The Adlingfleet community are setting up a network of people who are willing to check the defibrillator and BT kiosk. Resolved a two-month trial of a community noticeboard inside the BT kiosk can be tried.

29.4 GDPR. SSL certificate offered by Vison ICT at £125 for first year. Willing to add a footer to the website re Vision Privacy Statement. No GDPR officer now needed due to government intervention. Noted. Resolved nothing further is required from vision ICT.
