#### 109/1920 WARD COUNCILLORS REPORTS

The following was received from Ward Councillor L Sargeantson via email

In addition to the above (Justice Lane reply from ERYC) I can report that the recent speed awareness initiative in Reedness School was warmly received and I continue to work with the local policing team and any interested community groups throughout the Ward. sadly, the Community Speedwatch in the Marshlands is looking likely to fail due to a lack of engagement from residents. It is a great shame, these schemes work successfully elsewhere but despite the concerns voiced in the area, not many are willing to assist the community to address some of the issues. I would urge TR Parish Council to encourage concerned residents to contact Sarah Belton clerk to Swinefleet and Reedness PC's and consider working with the villages for a Marshlands wide scheme.

Much of my time, both day job and most evenings and weekends have recently been spent assisting the area of East Cowick and Snaith following the dreadful floods. This has included casework through Andrews office, site visits, liaising with the agencies and of course ERYC along with meetings. A disaster like this certainly focuses the mind and I am working with Goole Fields PC, Swinefleet PC and Reedness PC to apply for significant funding (we hope) to purchase appropriate pumps and discuss what other flood prevention measures can be purchased for homeowners using the Governments Flood Prevention Fund. Again, I would urge Twin Rivers to join the other Marshland villages to consider a joint application and sharing of resources. If you would like more details about this, please let me know and if necessary, we can arrange a separate meeting to cover the detail.

I met recently with Incredible Edibles and they updated me on their progress and excellent work they are delivering locally.

Bad weather impeded the recent roadworks throughout the Marshlands although most feedback was that residents welcomed the work being carried out.

My work colleague Julie Reed is working with Adlingfleet residents towards a funding bid offering improvements to the Church and community facility. An application has recently gone into the Goole Fields wind farm

In my role as chairman of the Twin Rivers Wind Farm fund we are actively encouraging small and large community groups to apply for funding and so I would encourage the PC to promote this opportunity through any of the groups you know or are involved with. This money is available to be allocated and we really need to encourage residents to apply, otherwise it will be spent out of area.
