5/2021 ONGOING ISSUES

5.1 Ousefleet Community Hall. The hall is currently closed due to Covid 19 regulations. The committee will apply for a small ERYC grant to meet its bills and loss of income. The hall has been donated a 3d printer which will make visors for staff at local care homes and for anyone who feels they need one for protection. The VE day celebrations, picnic in your own garden on 8 May 2020 was supported by the hall committee who distributed bunting and flags to residents. Coins were presented to local school children. It is hoped an actual celebration can take place on VJ Day 15 August 2020. The office of Andrew Percy MP have donated £250 towards making visors for the community. Ruth Robinson has also donated £70 towards the visor printing, after her little crochet rainbows were sold in the community.

5.2 Parish Council Penfold. Grow your own application from a resident. A further application has been made from another resident. A gate has been placed on the site to help the volunteer grass cutters keeping the area tidy and free from weeds. A discussion took place with all the parish councillors supporting the decision, already taken, to keep this area as it is for the whole community. Resolved to keep the area as it is currently, a full 100% decision. This

item can be taken off the agenda as there are no issues with the 3 volunteers keeping the site tidy without any costs to the parish council.

7.4 Big Lane rights of way. Reply awaited from L Whitehead. Update L Whitehead has retired and new officer S McGivern to be invited to survey the area. Noted that this cannot take place currently.

8/2021 CORRESPONDENCE

8.1 The Coach House Whitgift. Update requested from Ward Councillor L Sargeantson.

8.2 Letter from Groundwork re Incredible Edible Marshland. The Chair stated that the parish council owned no land suitable for the mentioned planting projects so are unable to give any authority within Ousefleet/Whitgift. No financial support is necessary for any projects at this time as we are still operating under restrictions of Covid 19. Applications must be made to ERYC and the Environment agency and other land agencies for planting approval. An email dated 23 April 2020 from a resident was informative re delivering hot food through the Half Moon public house and the donation of a grow your own veg box together with spring bulbs for 2021 for every household. Plans at the end of lockdown are not being thought about currently, a parish council cannot just support one business but serves the whole community and many businesses exist within the 3 villages. Ousefleet village hall continues to need community support and the hall committee will plan events when they are able to. The clerk was asked to send a request to be kept informed when indeed public gatherings are able to take place.
